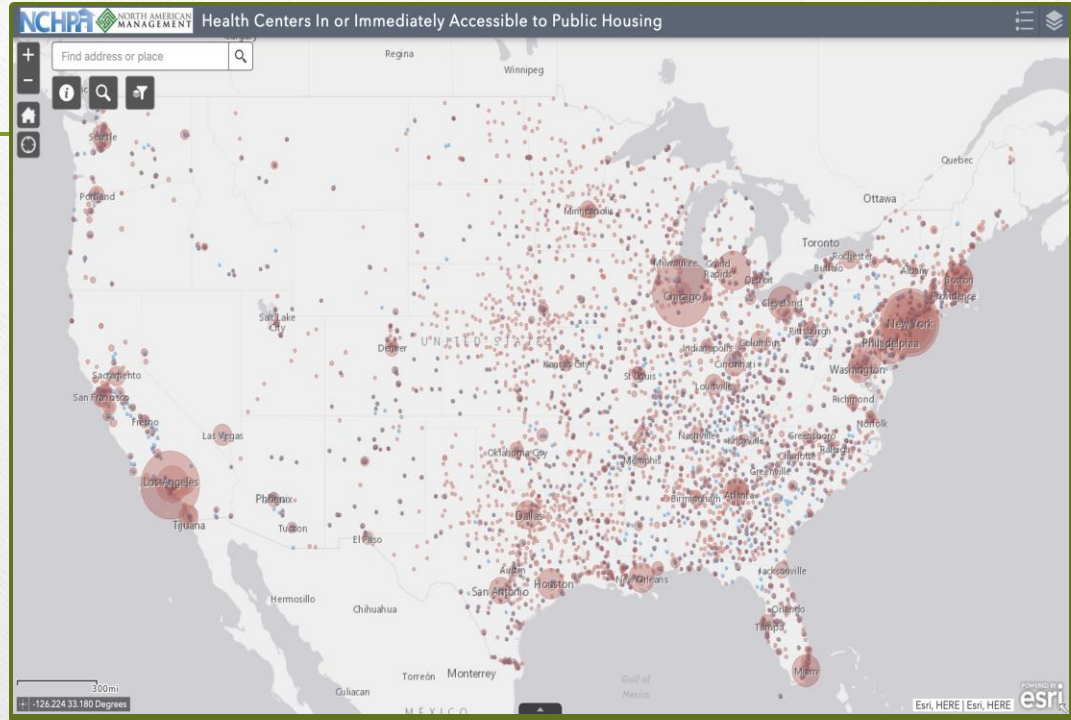

- 1,385 Federally Qualified Health Centers (FQHC) = 29.8 million patients
- 433 FQHCs In or Immediately Accessible to Public Housing = 5.1 million patients
- 108 Public Housing Primary Care (PHPC) = 856,191 patients

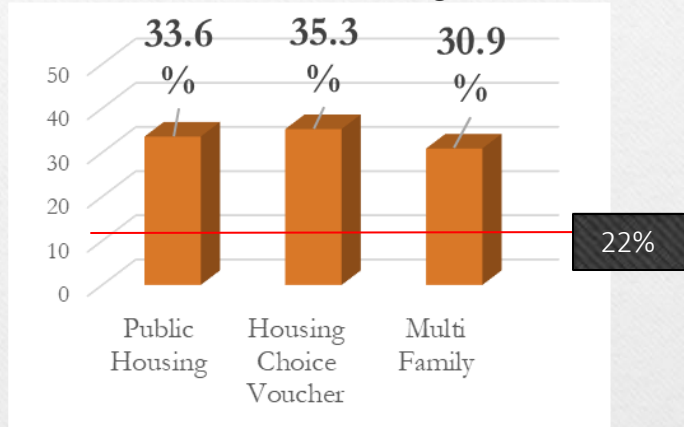

Adults in HUD-assisted housing have higher rates of chronic health conditions and are greater utilizers of health care than the general population.

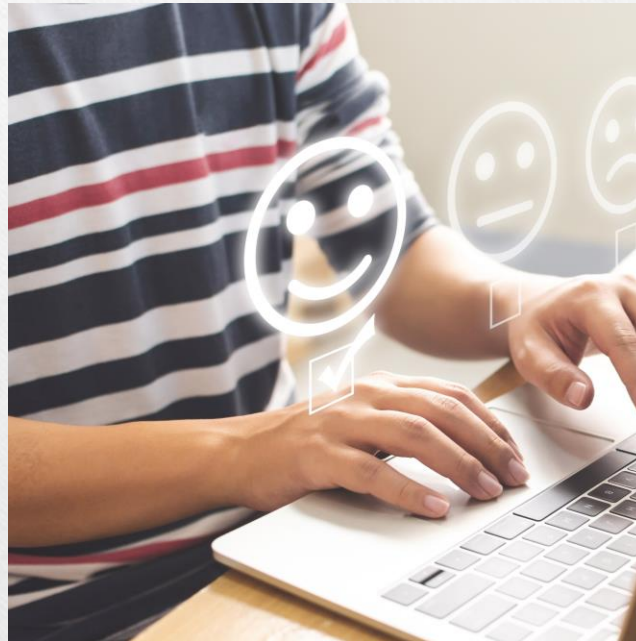
