














USDA Rural Rental Housing

HUD Housing Assistance Programs

Public Housing

- Federally funded and regulated
- Managed by local housing authorities who own the buildings

Housing Choice Vouchers (HCV)

- HUD's largest rental assistance program
- Monthly rental assistance payment to assist very low income families in renting housing on the privately owned rental market
- Popular with policymakers

Multifamily Project-Based Rental Assistance (PBRA)

- Contract is between HUD and owners of development
- If tenant moves, assistance stays with owner

HUD Housing Assistance

10 million individuals receive assistance; 4 million children


Housing assistance is not an entitlement: Housing assistance does not serve everyone who is eligible. Only one quarter of those eligible actually receive assistance.

Elderly and disabled make up over half of tenant households

Housing expenses crowd out other expenses

Program Eligibility: Citizenship, gross income, and household size

Race/Ethnicity: 64% Minority; 17% Hispanic







 - Family escrow account that grows as a family's earnings grow




