# Demographic Facts: Residents Living in Public Housing


The following demographic information was obtained from the U.S. Department of Housing and Urban Development (HUD), Resident Characteristics Report as of Feb 29, 2024, and the U.S Department of Housing and Urban Development (HUD), Picture of Subsidized Households.<sup>2</sup>



#### GENERAL INFORMATION

In 2023...

- About 946,733 public housing households are headed by residents between the ages of 25 and 61 (59%).
- The average household size for residents of public housing was 2.0 people and 2.2 people for residents receiving voucher funded assistance.
- 3.4 million residents receive voucher funded assistance (65%).



- 31% of public housing residents and 35% of those receiving voucher funded assistance reported households of one adult with children.
- 32% of public housing residents and 35% of people living in voucher funded assisted households are female headed with children.

#### **SENIORS**




- Nearly 642,000 or 40% of public housing households are headed by seniors (age 62 and above).
- Approximately 1.8 million or 35% of households receiving voucher funded assistance for housing are headed by seniors.


# PEOPLE WITH **DISABILITIES**

#### **INCOME**



• The average annual household income of a household for residents of public housing is \$18,284 and \$17,835 for households receiving voucher funded assistance. This falls well below the federal poverty line, which in 2023 for a household of two is \$19,720 and \$24,820 for a household of three.

#### DID YOU KNOW?



The primary source of income for 29% of public housing resident households is through wages, and 28% for residents receiving voucher funded assistance. However, despite the efforts of this working population, approximately 90% of public housing residents fall into HUD's "Very Low Income" category, with an income of less than 50% of the national median. The annual household income of public housing residents (\$18,284) is 25% of the local median.

## HEALTH STATUS



- Residents face several barriers to health. For example, safety concerns cause residents to spend more time indoors, reducing activity levels, and amplifying obesity and related issues.
- Additionally, where public housing is typically located in isolated areas, poor access to healthcare, social services and high-quality fresh foods are contributors to substandard health.<sup>3</sup>

#### POPULATION DISTRIBUTION

The following chart shows housing authorities across the country with the largest number of public housing and Section 8 units. This gives an estimate of locations with the largest number of public housing and Section 8 residents.<sup>4</sup>
